The cost to perform the work may not be the sole determining factor in the contractor selection. ## Request for Proposal 2019 US Highway 78/State Route 10 Concept Study From Hewatt Rd to Ross Rd

## Evermore CID Snellville, Gwinnett County, Georgia

The Evermore Community Improvement District (ECID) is seeking a professional consulting firm, experienced with transportation and community planning, to undertake the development of a Concept Study for US Highway 78/State Route 10. The Concept Study will follow US Highway 78/State Route 10 (Stone Mountain Freeway) from Hewatt Road to Ross Road with roundabouts at various intersections (Ross Road, Killian Hill Road, McDaniel Bridge Road, and Hewatt Road).

## **Background**

The Evermore CID is an organization of commercial property owners located on Highway 78, between Snellville and Stone Mountain, in Gwinnett County. The mission of the CID is to establish a vibrant, upscale destination area, improve business development opportunities, and enhance property values by developing and promoting coordinated transportation improvements and community character improvements to benefit property owners, business owners, and residents along the Highway 78 corridor.

## **Goals and Objectives**

The Concept Study must support the goals and objectives of the Atlanta Region's Plan. The purpose of these studies is to develop project concepts that improve safety, mobility and access to all roadway users, while also preparing them for advancement to Scoping and/or PE phases (in future TIP project solicitations). The goal of the RFP is to select the most qualified firm, at a fair and equitable fee, to be paid for services that will be negotiated following selection.

#### **Purpose**

The purpose of this study is to develop viable, multimodal, and cost-effective mobility solutions and to study the feasibility of short- and long-range alternatives in improving the efficiency, operations, and safety of the US Highway 78/State Route 10 corridor. The study will make project recommendations based on the following criteria and considerations:



- Consistency with the vision and goals set forth in the CID's Comprehensive Transportation Plan, the County's Comprehensive Transportation Plan and the Atlanta Region's Plan, which are available online
- Public and stakeholder support
- Potential to address the existing and future mobility needs of the corridor for all users
- Sensitivity to current and future land use
- Access management strategies to maximize safety and efficiency
- Safety throughout the corridor

The study will involve several tasks including the identification of information that is available and what is needed, and the next steps to be accomplished in the concept development.

#### Task 1 – Alternatives Evaluation and Draft Concept Report

In order to develop a meaningful concept, and reduce the need for later concept rework, some elements of Preliminary plans may be incorporated into the concept layout and Concept Report.

A valid concept addressing horizontal and vertical alignments is required and will contain such information as:

- Discussion and analysis of information identified at the Initial Concept Meeting.
- Design guidelines proposed.
- Context and setting design requirements.
- Landscaping requirements.
- Environmental survey results, specifically the results of the field surveys and agency coordination for historic properties, other Section 4(f) resources, cemeteries, wetlands, open waters, streams and their buffers.
- Design exceptions and design variances expected.
- Coordinated preliminary horizontal and vertical alignments.
- Typical sections.
- Edge of pavements.
- Post-Construction Stormwater BMP Locations.
- Some preliminary cross section work, including estimated construction limits.
- Preliminary capacity analysis including locations of proposed signalized intersections.
- Interface with adjacent projects.
- Intersection profiles with touch down points.
- Structural concepts (bridges and retaining walls).
- Constructability
- Right-of-way requirements.
- Utility requirements, including Public Interest Determination findings (if applicable).
- Preliminary driveway tie-ins.
- Preliminary construction cost.
- Preliminary right-of-way cost.
- Estimated Utility and Railroad cost.



- Utility and railroad requirements, determination if any at-grade crossings will be eliminated or upgraded.
- Determine railroad/traffic signal preemption study requirements.
- Need for Transportation Management Plan (TMP)

### Task 2 – Aerial Mapping, Survey Control and Property Database:

The goal of this task is to collect survey, mapping, topography, right-of-way (ROW), and property line data in accordance with GDOT's Survey Manual. Project photography flight(s) will be scheduled followed by digital mapping. All mapping done for GDOT projects will follow the latest electronic guidelines. Property investigations will begin and the results of this investigation will be entered onto a spreadsheet and used in initiating property owner notifications and to the Survey Party Chief for field verification of the required property corners.

#### Task 3 – Public Involvement

The goal of this task is to develop a planning outreach process that demonstrates to interested stakeholders the key design elements of proposed mobility solutions in the corridor. A concerted effort to reach out to senior, low-income and minority stakeholder populations should be made. The CID and its consultants will be responsible for designing an effective and innovative public involvement program with input from ARC.

#### Stakeholder and Public Engagement:

Minimum requirements are as follows:

- Engagement with the public at large will include educating about design alternatives and potential impacts, as well as, seeking input and consensus on preferred concept, typical sections or improvements. A variety of tools and approaches should be used, including social media, surveys, and hosting outreach activities in the study area (e.g. at schools, churches or businesses along the corridor).
- Project information will be uploaded to a project website (hosted by the CID or the
  consultant) to provide basic project information to the public, and shall include project
  materials, meeting summaries, and design alternatives being considered, and shall
  provide the opportunity to leave feedback. Project information and opportunities for input
  should also be shared on social media.
- Stakeholder involvement to include agency coordination with GDOT offices, Gwinnett County, City of Stone Mountain, DeKalb County, City of Snellville and other agencies as determined necessary
- A demonstrable effort shall be made to include persons or organizations that are or represent low-income, minority, persons with disabilities, or other disadvantaged stakeholders within reasonable proximity to the proposed study area.



#### Task 4 – Prepare Project Deliverables

The following shall be developed and submitted to Evermore CID in the format indicated below:

- Summary report that includes the study purpose and outline of the process, map of study area, summary of findings from the traffic analysis, crash and safety analysis and environmental scan, preferred and alternative concepts. Additional documentation and raw data may be attached as appendices, including:
  - Full traffic report including traffic counts, turning movements and other raw traffic data
  - o Environmental/historic resources scan memo or survey
  - o Right-of-way survey, data or mapping files
  - Any other raw data or documentation required for the concept development or Concept Report
- Draft Concept Report
- Preferred and Alternative Conceptual Plan Layouts and Typical Sections

#### Format:

- Single combined PDF file of the final report document which includes the summary report, concept layout, typical sections and the remaining full documentation as appendices (as described above).
- In addition to the final report, please provide *individual* PDF files of each of the following:
  - o Preferred and alternative concept plan layout and typical sections
  - o Traffic study
  - o Environmental/historic resource scan memo or survey
- One (1) printed final report document and appendices in 8.5"x11" and concept plan and typical sections in 11"x17".
- PDF of a draft preliminary GDOT Concept Report
- A USB thumb drive containing electronic files in their original formats with supporting graphics and GIS or other data files (Word, Excel, InDesign, CAD, etc.).

#### **Qualifications and Capabilities**

Qualified firms must demonstrate competence and experience in all areas of expertise required by the scope of services, including but not limited to multi-modal transportation planning and design, economic development, land use analysis, project costing and prioritizing future transportation needs.

Qualified firms must also demonstrate competence in graphic and oral communication to large and diverse groups and expertise in facilitating consensus from multiple public and private interests related to the project. In addition, the firm must demonstrate the ability to develop large-scale projects and present samples of similar projects developed in Gwinnett County, Atlanta and / or other metro areas, which have been successful in creating a positive, upscale image.



Inasmuch as the proposed ECID improvements directly affect business and real estate interests, qualified firms must also demonstrate experience working successfully with a variety of property and business leaders, as well as governmental entities, municipalities and other CIDs.

#### **Study Approach**

The Concept Study will extend parallel US Highway 78/State Route 10 (Stone Mountain Freeway) from Hewatt Road to Ross Road and will be managed by the Executive Director of the Evermore Community Improvement District. The consultant team will review the comprehensive plans of Gwinnett County, all regulatory ordinances, and the ECID Comprehensive Transportation Plan recommendations. A meeting will be held, most likely at the Evermore office, to present initial findings to the public. The Evermore CID board and staff, along with representatives from the selected study firm, will ensure public engagement to provide guidance and input for the possible plan.

#### **Costs for Preparation**

Neither the ECID, Gwinnett County, nor ARC is responsible for costs incurred by anyone responding to this Request for Proposal.

#### **Content and Length**

Responses to the RFP are limited to twenty (25) pages. At a minimum, the following shall be included:

- Experience working with creative solutions to transportation and community design projects,
- If using subcontracting firms, they must be identified and qualified,
- References for the firm, as well as for their subcontractors,
- Project approach,
- Availability of key personnel and percentage of time that key staff will be assigned to the project,
- Rate schedule for all personnel participating in study, and
- Fee proposal

The final study results shall include a single unbound copy, and the consultant shall provide ten (10) printed and bound copies (in color), along with three (3) electronic copies of the document and graphics to the CID on a flash drive. All contents, graphics, maps, products, etc. generated by this project will become the property of the CID.
